



Youth Club Contest Rules

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

2. How to Enter:

Brazos Valley Schools Credit Union's "Kids' Club Deposit Promotion" will begin April 2, 2018 and end on April 30, 2018 ("Prize-based Savings Account Promotion Period").

To Enter Automatically: A Brazos Valley Schools Credit Union member automatically receives Prize-based Savings Account Promotion entries based on the following:

One (1) entry for every deposit made into a qualified Kids' Club savings account during the promotion period. Automatic entries are only eligible to win during the drawing period covered.

3. One (1) \$25 BVSCU MasterCard Gift Card will be awarded per branch. Prize is not transferrable. Winner will be randomly selected from all eligible entries and contacted by phone or email on May 1, 2018. Parent of winner must provide valid identification to collect prize on behalf of minor child.

4. Actual odds of winning depend on number of eligible entries received.

5. Legal residents of the United States (except where prohibited by law) are eligible to participate and win. All participants must be at least five (5) years old but no older than (17) who are listed on a BVSCU Kids' Account and a member in good standing in the Credit Union. Employees of BVSCU, its subsidiaries, and the immediate family of any such persons (spouse, parents, siblings and children and each of their spouses) and persons living in the same household of each of these individuals whether related or not related, are eligible to win.

6. By participating in the Promotion, entrants agree to abide by and be bound by these Official Rules, and to accept the decisions of the Credit Union as final. Entrants also agree to hold the Credit Union and each of its officers, directors, employees, members and representatives, and agents harmless from any liability arising from participation, or the acceptance of a prize. The Credit Union and each of its officers, directors, employees, members, and representatives, and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance of prizes awarded or participation in this Promotion. The Credit Union is not responsible for stolen, lost, late, misdirected, damaged, incomplete, illegible, or postage-due mail or entries; or for transactions that are processed late or incorrectly, or are lost or not received due to any reason. The Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the Promotion and prize redemption.

Each winner agrees to permit the Credit Union to use his/her name and likeness in promotional and other Credit Union materials, without additional compensation or permission, except where prohibited by law. Each winner also agrees that their name and prize amount will be given to other entrants upon request.

Except where prohibited, entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Texas. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of Texas, without giving effect to any choice of law or conflict of law rules (whether of the State of Texas or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Texas.
